About this Report

As part of its participation in The National Citizen Survey™, the City of Collinsville conducted a mailed survey of 1,600 residents. Surveys were mailed to randomly selected households in February 2019 and data were collected through March 2019. After the official data collection period was underway (see the report, *The National Citizen Survey: Community Livability Report, Collinsville, IL, 2019*), the City made available a web-based survey to its residents through a link on the City's website. Visitors to the site were able to complete the survey during March I can2019 and 285 surveys were received.

This report contains the results of this administration of the web-based survey that have not been weighted to current population estimates of Collinsville.
