#### **DEFINITIONS:**

"Terminal operator" means an individual, partnership, corporation, or limited liability company that is licensed under the Illinois Video Gaming Act and that owns, services, and maintains video gaming terminals for placement in licensed establishments, licensed truck stop establishments, licensed fraternal establishments, or licensed veterans establishments.

"Video gaming terminal (VGT)" means any electronic video game machine that, upon insertion of cash, is available to play or simulate the play of a video game, including but not limited to video poker, line up, and blackjack, as authorized by the Board utilizing a video display and microprocessors in which the player may receive free games or credits that can be redeemed for cash. The term does not include a machine that directly dispenses coins, cash, or tokens or is for amusement purposes only.

"Licensed Establishment" any retail establishment holding a valid City of Collinsville Class A, B, B-1, E, or F liquor license.

### **LOCAL REGULATIONS:**

- 1. A valid City video gaming establishment license must be clearly displayed at all times.
- 2. A valid City video gaming terminal permit sticker shall be clearly displayed at all times on each video gaming terminal.
- 3. No video gaming terminal may be played except during the legal hours of operation allowed for the consumption of alcoholic beverages at the licensed establishment pursuant to Chapter 5.08 (Liquor Code) of the Collinsville Municipal Code.
- 4. The licensed establishment must fully comply with the Illinois Video Gaming Act (230 ILCS 40/1, et seq.) and all rules, regulations and restrictions imposed by the Illinois Gaming Board.
- 5. The licensed establishment must fully comply with Chapter 5.08 of the Collinsville Municipal Code and all other provisions of the Collinsville Municipal Code as well as Federal and Illinois law and regulations.

## **ANNUAL FEES:**

- \$500.00 Video Gaming Establishment License, due upon application submittal.
- \$250.00 Video Gaming Terminal Permit Sticker Fee, this fee is per video gaming terminal operated or set up for operation.
- \$1,000.00 Video Gaming Terminal Operator License, this fee is per location.
- \$2,000.00 Video Gaming Manufacturer/Distributor/Supplier (if located in Collinsville)
