Home Occupation Registration Application Checklist & Guide

City of Collinsville Home Occupation Registration Application
Copy of valid County Health Certificate (if preparing food)
Permission letter from property owner/authorized agent (if renting your residence)

City Requirements

Home Occupation Registration: All home-based businesses operating in the City of Collinsville that are considered a non-profit, civic, or fraternal organization or those <u>exempt by Illinois Statute</u> are required to have a valid Home Occupation Registration. The Home Occupation Registration must be renewed on an annual basis (no fee for application or renewal). Attached is the Home Occupation Registration Application. Zoning: The City of Collinsville allows Home Occupations in all residential zoning districts to provide residents with an option to utilize their homes as places to enhance or fulfill personal economic goals. The guidelines and intent set forth by the City serve to ensure a Home Occupation does not alter the essential residential character of the neighborhood in which it is operated, does not infringe upon neighbors' enjoyment of their property, and does not overly burden any public infrastructure such as roads, water, or sewer. The attached Application has a checklist of specific requirements that must be followed to obtain, and maintain, a Home Occupation Registration.

Food & Beverage Tax: In January of 2018 the City adopted Ordinance 18-10, establishing a 1% Food and Beverage Tax as an effort to assist funding the City's Park and Recreation Department. This requirement applies to all establishments that prepare food and beverage for immediate consumption by the public, including mobile food vendors and caterers. County Requirements*

*The City of Collinsville is located within two counites. Health Department approval is required for the county the business will operate in.
