
# NEIGHBORHOOD IMPROYEMENT

## Echo Hill (1)

#### Top Concerns

- ◆ Survey respondents were asked to rate their level of concern for 12 topics as either 'Very Concerned', 'Somewhat Concerned', and 'Not Concerned'.
- ◆ Based on the survey results, residents of Echo Hill appear to be concerned about the quality, condition, and safety of pedestrian and vehicular transportation infrastructure in their neighborhood and maintenance of properties.



## **Tools for Improvement**

#### **Capital Improvement Plan (CIP):**

allows the City to forecast capital costs, funding and timing for large projects. Each year, City departments plan out projects and improvements based upon needs, policies, programs, and adopted plans. capital improvement the CIP is reviewed by the City Council.

### Tools for Improvement


#### Bicycle and Pedestrian Plan (Purple Path): The
