In the spring, as part of our goal to revitalize our Uptown, we started work on the Collins Park Project by demolishing the Main Square Apartments & the Martha Manning warehouse buildings and moving the DD Collins House to its final resting place at the center of the New Collins Park.

This past summer, we saw the completion of the Summit Avenue & South Clinton Street Bridges, both much needed infrastructure upgrades for our community.








## BACKYARD CHICKENS ARE NOW ALLOWED IN COLLINSVILLE

In November, the Planning Commission recommended, and the City Council approved, an ordinance allowing Collinsville residents living in single family owner-occupied homes to keep backyard chickens. Permits are required, and there are specific restrictions and requirements to ensure the health of the chickens and the safety of the neighborhood.

Roosters are not permitted, and up to 6 chickens may be kept, based on the overall size of the lot. The chickens are restricted to the rear yard only and must be provided with an adequate coop and "run" space. Only 75 permits will be issued while the program is being evaluated, and the \$50 permit is valid for 3 years. The ordinance becomes effective on December 23rd.

WINTER WEATHER IS JUST AROUND THE CORNER! It's hard to imagine with such unseasonably warm weather so far this December, but it will eventually snow. City Road Crews are ready and waiting, and would like to ask that City residents remove their vehicles from the street whenever possible to allow the crews to do their job. We don't want to snow you in, but have no other alternative when vehicles are parked on the street. Just a temporary move to a driveway for a few hours helps!

### CODE ENFORCEMENT:

**BUILDING PERMITS NEEDED:** Not much outside construction going on in the winter, but please remember that some indoor work needs building permits too!

Drywall, electric, plumbing, and HVAC work requires inspections and in some cases, a licensed contractor.

Minor maintenance and improvements like paint, carpet, or floor tile do not require permits, but if you aren't sure, please call the Building Department at 346-5200 ext. 1126.

The City is experiencing an increase in the number of complaints received on broken down and/or unlicensed vehicles. City Code requires that all vehicles are lawfully licensed, and failure to obtain a valid license sticker is a violation of both State and Local Law.

Additionally, broken down or inoperable vehicles must be stored off site or inside your garage. This includes flat tires and vehicles that are not drivable due to accident or lack of maintenance. These vehicles cannot be parked in the street and doing so may result in citation, fines and penalties.

With winter weather and freezing temperatures closing in, we would like to remind all of our customers to make sure they have unhooked all their hoses from exterior faucets and closed up any outside doors or trailer skirting to prevent pipes in crawl spaces from freezing.

## MEDICAL MARIJUANA DISPENSARY COMES TO COLLINSVILLE

In August 2013, Illinois Governor Pat Quinn signed into law the Compassionate Use of Medical Cannabis Pilot Program Act (the "Act"). The Act made it legal for qualifying patients to consume medical cannabis that is grown and distributed through state-licensed facilities. One such facility will be located in East St. Louis, IL.

The Act limits access to patients that suffer from a specific list of medical conditions, that have been pre-qualified through a rigorous certification process. Currently, the program specifies approximately 40 qualifying medical conditions, including conditions like cancer, Parkinson's disease, seizures and HIV/AIDS. Governor Rauner recently vetoed a bill expanding the list of qualifying conditions, although the expansion had received preliminary approval. Included were migraine, PTSD, IBS, osteoarthritis, and 7 other conditions.

A limited number of grow centers and dispensaries were authorized, with an application/legal process that included extensive public input and significant financial investment. Two dispensaries were approved within the 5-County wide Illinois State Police District 11, which includes Madison and St. Clair Counties, one in Sauget and the other in Collinsville.

The Collinsville dispensary is owned and operated by HealthCentral, Inc. or HCI Alternatives, that also operates a second location in Springfield, IL. The Collinsville site is located at 1014 Eastport Plaza Drive, less than a block from the State Police Headquarters building.

Security is a high priority at the facility, where over 40 surveillance cameras will operate on a 24/7 basis. A concrete-lined vault houses the products and a protective sally port is in place to further limit access. Credentials are checked at the door, with only those authorized being allowed through locked doors past the waiting room.

The facility will employ 25-40 full and part time people, and is expected to be operational by the end of December. For more information, please visit [www.hcillinois.com](http://www.hcillinois.com). ### KEEBLER & BELTLINE INTERSECTION

Thanks to the Federal Congestion Mitigation and Air Quality (CMAQ) grant program the intersection at Keebler and Beltline will receive a major transformation next summer. Half the funding comes from CMAQ, and matching funds will be split between Madison County and the local Northeast Business District at an 80/20 rate.

The project consists of acquisition of right-of-way (completed in 2015), relocation of utilities (currently underway) and installation of turn lanes in all directions (being bid out in January with construction starting after award of bid). This is a great project that will make a large impact on a very busy intersection.

### MAIN STREET WATER MAIN PROJECT

The City's water crew has been busy replacing water main in the Uptown Area. Replacement of this century-old water main will be a big improvement to our water distribution system and will improve fire protection by adding new hydrants. Clay Street has been recently completed and work will now begin on East Main. In January, the installation of 10" water main will begin along West Main from Highway 159 to Summit Avenue. The crew will work on 2 blocks at a time before moving on to the next 2 blocks; please drive carefully in this area for the safety of the workers.

***Streetscape Phase IV Starts in April 2016***

The latest Streetscape Project will consist of new water lines, curbs, sidewalks and ADA accessible ramps. Street trees and decorative street lamps will highlight Main Street from Vandalia to Aurora, then over to Clay Street and onto Chestnut. This project is scheduled to be completed by the Fall of 2016.

In addition, Governor Rauner has ordered that the flag of the United States and the Illinois Flag be flown at half staff from sunrise to sunset for 2 days preceding the funeral of any fallen Illinois soldier, and on the day of his/her funeral.

Locally, the flags may be lowered to recognize the passing of a police officer, firefighter or other well known dignitary. **...And now you know!**
