A Note from Mayor Miller

Summer is in full swing. Vacations are being taken, family picnics are the norm, and July 4th is only days away. Having said that, I'd like to remind everyone to have a fun, but safe July 4th holiday.

It is important to note that fireworks are illegal inside Collinsville City limits; however, "consumer fireworks" such as sparklers and fountains are allowed. The consumer types of fireworks are generally weaker in explosive power compared to professional displays and include snake or glow worm pellets, smoke devices, party poppers, snappers, trick matches, etc.

Many residents may be unaware that several well-known types of fireworks such as firecrackers, bottle rockets, and Roman candles are wholeheartedly illegal not just in Collinsville, but also in the State of Illinois. I urge you not to stray from the law by purchasing and displaying these kinds of fireworks. Our City is firm in what we do and do not allow each July 4th.

Any other type of firework and/or pyrotechnic display, are strictly prohibited. Anyone caught violating City code will be subject to a fine and confiscation of all illegal fireworks.

Each July 4th the Collinsville Police Department works hard to patrol our community. They want to ensure that our residents are celebrating safely and obeying the law. They are always ready to respond to reports of illegal firework activity and/or other complaints. Similarly, the Fire Department is on-call and prepped to respond as well. Thankfully, there have not been any firework related injuries or fire reports related to fireworks in the last few years! That alone is fantastic news and I hope we can keep up the good work.

July 4th is a special time for friends and families everywhere. It is the true mark of the summer season and the last big weekend before kids go back to school and our lives get hectic again. I personally enjoy this time of year and I hope you all will enjoy the holiday while staying safe. Have a great summer and we will see you all in the next edition of *The City Scoop* in September!

Streetscape Phase III Update - City Hall

If you have been up to City Hall in the past several weeks, you have noticed our dust. The major reconstruction taking place in front of the building is Phase III of the City's Streetscape program.

This phase will reconfigure the area around City Hall, creating a new, more pedestrian-friendly entrance and will also include streetscape improvements along Center and Church Streets. The streetscape improvements include new handicap accessible sidewalks, curb and gutter replacement, the installation of historic light standards, decorative street signage, street trees and grates, new trash receptacles and stamped brick crosswalks.

Each phase of the Streetscape Project has been and will continue to be paid for though State and Federal Grants that the City has applied for. For example, the City received \$1.25M from the *Illinois Transportation Enhancement Program* (ITEP). This money comes from the Federal Transportation Bill and is prorated to each State. Furthermore, the City received an additional \$250K from the *Green Streets Program*. That is a total of \$1.5M in grant money to fund Phase III of this project.

While the total cost of Phase III is \$1,875,000, that leaves a remaining 20% balance which the City will pay for though TIF (Tax Increment Financing) funds. TIF is the only locally controlled economic development tool available to Illinois communities. It allows municipalities to self-finance redevelopment projects (like the Streetscape program) in an effort to revitalize areas that are essential to the economic well-being of our community.

Upon completion, a more beautiful City Hall will be revealed boasting impressive landscaping in a courtyard-type setting with decorative benches, flagpoles, and charming Uptown lighting. This is just one more proactive approach City staff is taking to beautify our community. We continue to strive for excellence in making Collinsville the preferred place to live and work!

From Post Office to Parking Lot

Last August, the City of Collinsville received a petition signed by 28 Main Street business owners urging City officials to purchase the site of the former Post Office. It was their hopes to utilize that space to create a public parking lot. Just a few short months ago, the City purchased the property.

Demolition, performed by the Collinsville Street Department, began the week of June 23rd. Bids for the construction of the new 50-space parking lot were opened on June 20th. The project was awarded to the lowest bidder, Hank's Excavating.

Mayor John Miller is thrilled to see this go through, "This is an exciting opportunity to lessen the demand for parking spaces Uptown. By creating 50 new spaces, we are able to offer a much needed convenience factor to the patrons of City Hall as well as to the businesses in the heart of the Uptown commercial district."

Uptown Coordinator Leah Joyce is pleased that this type of project will assist in the revitalization of the Uptown area, "A new up-to-date parking lot like this will further our efforts in creating a more appealing Main Street for potential new businesses."

The proposed completion date of the new public parking lot is Fall 2014; stay tuned!

Ruler Foods: By the end of the year, a new discount grocery store has plans to open in the Orchard Shopping Center on Vandalia. The bag-your-own grocer is similar to Aldi's but is owned by Kroger and will primarily stock Kroger branded merchandise.

Yard of the Month Program in Full Swing

The purpose of the Yard of the Month (YOM) Program is to recognize Collinsville residents who devote their time improving and maintaining immaculate landscaping and yards. Nominated yards are judged by members of the City's all-volunteer Community Appearance Board, who select a first place winner and a runner-up.

The Collinsville Community Appearance Board is a volunteer organization that is responsible for various initiatives relating to the beautification of the City. One of their many administered efforts is the Yard of the Month Program.

This YOM Program runs from May to October each year. Monthly first place award recipients are recognized at televised City Council Meetings, on the City's website, www.collinsvilleil.org, here in *The City Scoop*, on City of Collinsville Television (Charter channel 993, AT&T U-Verse channel 99), and various other media outlets such as Facebook and Twitter.

While the Yard of the Month has been very successful in the past, the Community Appearance Board tweaked the program a few years back to further incentivize participation.

Several Collinsville businesses make generous monetary contributions to the Board which allows monthly winners to receive gift cards to sponsoring businesses. \$50 gift cards to Creekside Gardens are awarded to 1st Place winners and \$20 gift cards to Rural King go to the runners-up.

Additionally, every Fall, visitors to the City's website will be asked to cast their vote for their favorite yard of the six monthly winners. The yard with the most votes will be recognized as Collinsville's Yard of the Year. The Yard of the Year winner will be awarded a gift card and recognized at a community event.


