## ALCOHOL COMPLIANCE CHECKS

In a continuing effort to discourage underage alcohol consumption and to deter alcohol outlets from selling alcohol to underage youth, the Collinsville Police Department conducts periodic alcohol compliance checks within the city. We believe the use of these compliance checks will decrease alcohol sales to minors and reduce alcohol-related injuries. By decreasing alcohol availability, we believe that these compliance checks will also reduce alcohol-related problems and crime amongst youth.
